Year End Giving...

 \mathcal{R} equired Minimal Distribution- Qualified Charitable Distributions (QCD) from an IRA or Roth IRA permits taxpayers, age 70½ and older, to make donations directly to public charities without counting them as part of their adjusted gross income . Garvey Manor would be pleased and honored to receive such a distribution. As a 501(c)(3) non-profit organization, such contributions are tax deductible to the extent permitted by law.

How Our Ministry Began...

O ur ministry began in the 1960's when Bishop J Carroll McCormick of the Altoona-Johnstown Catholic Diocese of Pennsylvania had the foresight to realize there was a need for a Catholic home for the aged in the Diocese of Altoona-Johnstown. To meet the growing need to care for the elderly in that region, 18 acres of land located in rural Hollidaysburg was purchased by the diocese. The new facility was named after the first Bishop of the Diocese, Eugene A.

Garvey.

Bishop McCormick wanted the very best care for the people who



would make Garvey Manor their home. He was familiar with the works of the Carmelite Sisters for the Aged and Infirm whose foundress was dedicated to enriching the lives of the elderly in ways that were unique, exceptional, and person-centered. He invited the now Venerable Mother Mary Angeline Teresa, O. Carm., the Foundress of the Carmelite Sisters for the Aged and Infirm, to send sisters to direct the mission and ministry at Garvey Manor. In 1965 the doors of Garvey Manor opened. The ministry of providing care to the most vulnerable of the population, the aged and infirm, began at Garvey Manor under the administration of the Carmelite Sisters for the Aged and Infirm.
